# Responsibilities

## Time Period Definitions

**Twilight-** Starts 4:00pm Mon-Thurs, after 3:00pm Fri-Sun and holidays

**Sundowner** -Within last 2.5 hours of each day

**Junior-**Must be accompanied by a parent if under 16 years of age

**Holidays-**Rates will be equal to Friday - Sunday schedule

## Booking Responsibilities

As part of your Corporate Member status, you are extended the privilege of booking up to nine (9) days in advance. This means you can book for a Saturday on the Thursday previous. Please note this is two days in advance of the public giving you exceptional value when booking your tee times. Tee time availability is subject to advance group bookings. Transferability means another golfer can play with this program but will be applicable to the enclosed rules and must have a confirmation number to receive all applicable discounts.

## Member Responsibilities

The member agrees to book tee times in a responsible manner. This includes showing up with the same number of players booked and canceling tee times not used. Any changes in the number of players or cancellation of tee times must be done the day prior to play.

Failure to book and use tee times responsibly (as noted above) will result in the following:

**1st offence** – email from Head Professional

**2nd offence** – Phone call from Head Professional

**3rd offence** – Credit card on file (required) charged \$25.00 for each no show guest

**4th offence** – Credit card on file (required) charged \$25.00 for each no show guest

**5th offence or more** – Credit Card charged \$50.00 for each no show guest.

The member who books the time is responsible for the quantity of all the members of their group. Corporate Member responsibilities towards tee time bookings, cancellations, and no shows will be monitored diligently this season. Please note that Weather related No-shows will not qualify as an offence.

## Our Commitment to Your Privacy

The Ranch Golf & Country Club considers personal information to be only that information necessary to communicate information regarding the golf club, special events, functions and services, and utility related matters.

We will not disclose the personal information we have collected to anyone else and we will not permit anyone else to use your personal information for any purposes except as permitted by legislation or with your consent.

We will maintain all personal information in our possession in an accurate, complete, and up-to-date form as possible. Personal information shall be protected by appropriate safeguards put in place by The Ranch Golf & Country Club.

We will be happy to provide you with access to your personal information that we have in our possession. Upon request, we will make all appropriate corrections and updates to the personal information you have provided.

## Management

The golf course is privately owned and operated by The Ranch Golf and Country Club Ltd. The management and control of the Club is vested in the Board of Directors of The Ranch Golf and Country Club Ltd. And no person, firm or corporation other than the Board has any voice in the affairs of the Club.

## Club Property

No guest shall acquire any interest whatsoever in the property and assets of the Club. All property and assets belong to The Ranch Golf & Country Club Ltd.

# Rules

## General Rules and Conditions

1. The Club authorizes Club Employees to enforce the Club Rules and Regulations and to use such discretionary power as is necessary to ensure full enjoyment of the facility.
2. Any Guest using abusive language, breaking Club Rules or acting in a manner encroaching upon the rights of others, may be asked to leave and have their privileges revoked.
3. The Club is not responsible for golf clubs, equipment or personal effects belonging to Guests. Therefore, it is recommended that players ensure that their personal effects are covered by their own insurance.
4. All members and Guests must be appropriately dressed while on Club premises. A shirt, slacks or shorts and shoes must be worn at all times. Short shorts and bathing suits are not acceptable.
5. All players must have their own set of clubs at the start of play. No sharing will be permitted.
6. No alcoholic beverages are permitted on the golf course or in the Club House unless dispensed by the Club in accordance with A.L.C.B. Regulations.
7. Any complaints about employees or the operation must be in writing to the Director of Golf and signed by the complainant. Verbal complaints cannot be considered.
8. No article belonging to the Club shall be removed from the property.
9. Damage resulting from the actions of a Member or Guest shall be the responsibility of the offending individual or party. Expenses incurred by the Club as a result of such damages shall be repayable to the Club by the offending individual or party.
10. Children under (16) years of age must be accompanied by parents while visiting the club.
11. All guests are not permitted access to the Club Kitchen, utility rooms or storage areas.
12. No outside food and beverage are permitted on the golf course or within the clubhouse unless dispensed by the club.

## Rules Governing Play

1. All players must register at the pro shop before teeing off.
2. All players will check in with the starter before commencing play.
3. Players must at all times obey the directions of the Club staff.
4. Players are to maintain a pace of play target of 4:25 minutes or better.
5. Players may not start from the tenth (10) tees without permission from the Club staff. Players who have completed the first nine (9) holes are to continue their round with priority over players starting from the tenth (10) tees.
6. Players stopping between nines (9) may lose their place on the course subject to the discretion of the Club staff.
7. No competition or tournament may be played on the course without the approval of the Club staff.
8. Maximum four (4) ball foursomes only except at the discretion of the Club staff.
9. Play should proceed in a speedy and courteous manner.
10. It is the players duty to keep the course in good condition:
  - Repair your ball marks
  - Replace divots
  - Rake sand traps
  - Keep power cart at least thirty (30) feet away from greens & on cart paths where possible
11. Only power carts authorized by the Club are allowed on the golf course.
12. Looking for or the sale of used golf balls is strictly prohibited.
13. Players shall practice only in designated areas (driving range and practice green).
14. The turf care staff will have the right of way.
